The Department of Public Works hereby invites bids from experienced service providers for the servicing, maintenance, repair, upgrading, replacement and new works of electrical, mechanical and plumbing installations, plant and equipment installed in KwaZulu-Natal Provincial Administration Buildings and Institutions.

Only bidders who are registered on the Central Supplier Database and have valid CIDB registrations are eligible to submit Bids. Bidders should have CIDB Contractor grading designations of 1 ME, 1 EB, 1 EP, 1 SF, 1 SL, 1 SD, 1 SO, 1SI or higher.

Bidders must download and print the bid document free from the website and complete the document by closing date of bids together with submission of all other requested documents as required in the bid document.
