# **SECTION G**

# SPECIFICATION AND EVALUATION

#### 1. PURPOSE

The Department is seeking bids from Registered Professional Quantity Surveyor who has the relevant qualifications, registration, and expertise for the Project: Department of Health: Addington Hospital: Installation of a Backup Chiller.

#### 2. BACKGROUND

- 2.1 Addington Hospital's core block (or main tower) is provided air-conditioning via a water-cooled chilled water system. This system comprises of three sub-systems;
  - Four (4) chilled water generators (Chillers 1-4), located at the basement of the core block building
  - Six (6) cooling towers, four (4) units located at the roof of the 16th floor of core block and two (2) units at the roof of the Nurses Building
  - Multiple air-handling units (AHUs) distributed within the core block building
  - Basement plant room-two (2) masonry AHUs serving theatres complex and other areas
  - 2nd floor serving matrons 13th floor serving wards
  - 15th floor serving admin offices
- 2.2 Whilst the core block was undergoing façade renovations, around 2012 to 2015, a variation order was approved for the replacement of chilled water generators (Chillers 3 and 4), with two smaller capacity chillers (RC to Trane manufactured screw chillers). The motivation was to replace two chillers which had not worked since commissioning about 10 years prior, as the core block was functioning on one chiller whilst the other was beyond economical repair (chiller 2). During the construction works, modifications were done to the condenser pipe work in order to allow the chillers to function with the 2nd floor cooling towers. The modifications left Chiller 1 and 2 not operational and Chillers 3 and 4 in working state.
- 2.3 A project was then initiated to replace Chiller 2 as this was beyond economical repair. During the project activities of replacing chiller 2, it was noted that the other buildings, and parts of the core block, within Addington Hospital were not being given attention in terms of HVAC. These buildings are supplied air-conditioned air by systems separate from the main core block system. A project called "HVAC System Maintenance" was initiated to address the air-conditioning in these buildings.
- 2.4 The replacement of chiller 2 proposed to relocate the cooling towers from the 16th floor to the 2nd floor nurses building. This required information from a structural engineer on the suitability of the 2nd floor roof in taking the additional load of the cooling towers, thus the project had a dependability on another service which was not covered in the consultant's appointment. The project was then put on hold pending this investigation.
- 2.5 This investigation led to the creation of the project "Investigation of Services" because a need to answer questions related to the services (water supply, electrical supply, air-conditioning, hot water systems etc.) at the hospital had arisen.
- 2.6 This resulted in scope duplication between these multiple projects. This resulted in the HVAC System Maintenance project being put on hold and the Investigation of Services taking the lead. For the replacement of the chiller #2, it was agreed that the project would continue with the view of providing back-up to the smaller chillers as air-conditioning was critical to the core block, especially the theatres. The confirmation brief was then done with the detailed scope mentioned in the brief. The appointed consultant was Dihlase Consulting Engineers. The same consultant was appointed on the Investigation of Services for mechanical services.

- 2.7 HIAC approval was granted to proceed to Design Development on 07 January 2020. This concept report contained design recommendations, which were;
  - Separation of the condenser pipework mentioned before between the two levels of condenser cooling towers
  - Installation of Building Management System
  - New MCCP panel
- 2.8 The Concept & Viability Report had a project cost estimate of R 14 706 141.19. The recommendations had a cost estimate of R3 645 500 inclusive of VAT. In the submission of the FIDPM Stage 3 report, the consultants requested clarity on the approval of their recommendations as they feared not being compensated for the work done. The HIAC clarification letter was drafted and forwarded to the consultants via DoPW and stated the following: "It was requested that the detail design report needs to be done as a brand new report for FIDPM Stage 3: Design Development addressing the detail design and not include Stage 2 contents again, and that the report must feature the associated recommendations by the Professional Team to deliver a working design and will be reviewed at that stage"
- 2.9 After the HIAC clarification letter, the consultants went back and came back with revised recommendations different to the ones presented. The summary of recommendations is contained in Annexure and now total an estimate of R60 605 000.00 inclusive of VAT.
- 2.10 It is not clear how the original HVAC system was supposed to run in their original design configuration. This is now made complicated by the modifications that have been done to the system during the external façade works and by the maintenance personnel or others in the lifetime of the HVAC system.
- 2.11 This project now aims to resolve the above concern through a comprehensive upgrade of the HVAC system in the Main Tower Block. This means that the Concept stage of the project must be redone in order to determine the best possible solution to the HVAC system at Addington Hospital's Core Block building.
- 2.12 The Mechanical Engineering consultant, Dihlase Consulting Engineers, has already been appointed to this project and has been appointed as the Principal Agent.

#### 3. SCOPE OF WORK

The services required from the consultants are standard consultant project stages that are required to take a project through to successful completion of construction and are in line with the Framework for Infrastructure Delivery and Procurement Management (FIDPM) guidelines.

Detailed deliverables from the consultants are as per the schedule of relevant Government Gazettes in Table A below. Consultants are required to undertake the project through all stages, as per the respective government gazettes and departmental conditions of appointment of consultants.

#### 3.1 Scope of service:

The scope of work entails the following for the Main Core Block:

- a) Confirmation/provision of architectural as-built drawings of the core block (In 2D and 3D format)
- b) Confirmation / provision of mechanical (HVAC) and electrical (reticulation) services (in 2D and 3D formats)
- c) Provision of the co-ordination drawing (in 3D and 2D formats)

- d) Detailed Conditional Assessment of the current installed HVAC system
- e) Design of the HVAC system solution for the core block building and its services. Energy and efficient technologies to be investigated and properly documented.
- The design must produce a solution to the current situation that will have a known system layout, system operating philosophy and control logic.
- The HVAC system solution must be optimised and airflow in the ductwork to be demonstrated to be so (e.g., Computational Fluid Dynamics etc.)
- f) Design of the necessary electrical and controls required for the safe and efficient operation of the HVAC system
- g) Supply, Installation, and commissioning of a new HVAC system for the core block building and its services
- h) Production of handover documentation (i.e., commissioning reports, as-built drawings, close-out report etc.) as built drawings to be in 3D to show location of all equipment

The scope shall include but not limited to:

- Conditional assessment report to form part of the concept report
- Performing a detailed design of selected concept(s)
- Production of detailed Bill of Quantities for the HVAC system solution Construction, supervision, and commissioning of the final detailed designed of the HVAC
- system solution
- Production of construction and as-built drawings of the entire HVAC system solution, showing all components of the final solution, i.e., air-conditioning generation, air delivery and management, pumping schemes etc.
- Testing, balancing, and commissioning of the ductwork, if any, of the system
- Submission of testing, balancing, and commissioning data of the care block HVAC system solution
- Compiling and submission of operating and maintenance manuals of the core block HVAC installation.
- Training of the hospital maintenance personnel on the operation and maintenance of the HVAC system solution.
- Final hand-over of the core block HVAC system solution including all approved returnable documents.

The scope of services is as per the gazetted scope of services for Professional Quantity Surveyors administered by the South African Council for Quantity Surveying Professions including but not limited to:

- Preliminary and Detailed Cost Estimation
- · Compilation of Bills of Quantities

These rates will, however, only be adjusted on the first day of each calendar year irrespective of any changes in salary ranges during the relevant year. The rates applicable at the time of the execution of the work as set out in Table 8 of the "Rates for Reimbursable Expenses", as amended from time to time, may be claimed.
- C2.1.3.6 Additional Services
- C2.1.3.6.1 Additional Services pertaining to all Stages of the Project
  Unless separately provided for hereunder and scheduled in the Activity Schedule, no separate payment shall be made for the additional services. The cost of providing these services shall be deemed to be included in the value-based fee tendered for normal services.

### C2.1.3.6.2 Construction monitoring

The construction monitoring requirements are as specified.

- (a) If <u>Level One</u>, <u>part time</u>, monitoring has been specified then no separate payment shall be made for construction monitoring staff or for the transport of the monitoring staff. The cost of providing construction monitoring staff and transport shall be deemed to be included in the value based fee tendered for normal services.
- (b) If <u>Level Two, full time</u>, monitoring has been specified then provision shall be made in the Activity Schedule for the envisaged site staffing requirements as specified. The unit of measure shall be the rate per calendar month (pro rata for part of a month). Payment shall only be applicable for the period actually established on site and shall in no instance be prior to the date of official handover of the Works to the Contractor or after the date of issue of the Certificate of Completion for the Works contract. The rates tendered for the relevant site staff shall include full compensation for all costs including, inter alia, the following:
  - Salary
  - Additional allowances
  - Bonuses
  - Leave and sick leave
  - All company contributions such as provident fund, group life benefits, medical aid etc.
  - Levies
  - Office equipment
  - Relocation cost and accommodation
  - Travelling
  - Handling cost and profit.

Payment for personnel shall exclude any periods of leave or sick leave. Time sheets for staff shall be included in the monthly fee account submitted to the Employer for payment. Replacement of staff as a result of any extended period of leave or sick leave outside of the normal contractor's year end break shall be to the approval of the Employer.

No separate payment shall be made for the transport of the construction monitoring staff and the cost of the transport shall be deemed to be included in the monthly rate tendered for the provision of the staff.

# C2.1.3.6.3 Occupational Health and Safety Act, 1993 (Act No. 85 of 1993)

No separate payment shall be made for the service specified. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

### C2.1.3.6.4 Quality Assurance System

No separate payment shall be made for the implementation of a quality management system as specified. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

### C2.1.3.6.5 Lead Consulting Engineer

No separate payment shall be made for assuming the leadership of an Employer specified joint venture, consortium or team of consulting engineers as specified. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

### C2.1.3.6.6 Principal Agent of the Client

No separate payment shall be made for assuming the role of principle agent of the Employer if specified. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

### C2.1.3.6.7 Environmental Impact Assessment

No separate payment shall be made for the service specified. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

# C2.1.3.6.8 Other unspecified services

The Employer may order duties that fall outside the scope of the project as tendered. Such additional duties may involve, but not limited to:

- Additional design requirements
- Evaluation of alternative tenders
- Additional investigations during the Defects and Liability Period
- Diverse other services

Any such additional services that may be required will be remunerated on a Time Basis as set out. The level of expertise necessary for any such additional work shall be concomitant with the issues to be addressed. The category of personnel necessary to undertake the work shall be approved by the Employer. Any additional identified service shall be fully scheduled and submitted to the Employer for approval prior to the commencement thereof.

#### C2.1.4 Time based fees

### C2.1.4.1 Fees for work done under a time based fee

Where time based fees are payable (if basis of remuneration has been set at "time basis" according to the bid as per the NDPW Rates.

C2.1.4.3 Work will be remunerated for at the category level in which it falls as defined above, irrespective of whether the person who in fact executed the work functions at a higher category of responsibility and competence.

## C2.1.5 Set off

The Employer reserves the right to set off against any amount payable to the Service Provider, any sum which is owing by the Service Provider to the Employer in respect of this or any other project.

# C2.1.6 Typing, printing and duplicating work and forwarding charges

## C2.1.6.1 Reimbursable rates

The costs of typing, printing and duplicating work in connection with the documentation which must of necessity be done, except those which must in terms of the relevant Manual or other instructions be provided free of charge, shall be reimbursable at rates applicable at the time of the execution of such work. The document "Rates for Reimbursable Expenses" as amended from time to time and referred to below, is obtainable on the Employer's Website: : <a href="http://www.publicworks.gov.za/">http://www.publicworks.gov.za/</a> under "Documents"; "Consultants Guidelines"; item 1.

### C2.1.6.2 Typing and duplicating

If the Service Provider cannot undertake the work himself, he may have it done by another service provider which specialises in this type of work and he shall be paid the actual costs incurred upon submission of statements and receipts which have been endorsed by him confirming that the tariff is the most economical for the locality concerned.

If the Service Provider undertakes the work himself, he shall be paid in respect of actual expenses incurred subject to the maximum tariffs per A4 sheet as set out in Table 1 in the "Rates for Reimbursable Expenses".

Typing and duplicating expenses shall only be refunded in respect of the final copies of the following documents namely formal reports, formal soil investigation reports, specifications, feasibility reports, bills of quantities, material lists, minutes of site meetings and final accounts. The cost of printed hard covers shall only be paid in respect of documents which will be made available to the public such as bills of quantities and specifications or where provision of hard covers is specifically approved.

The typing of correspondence, appendices and covering letters are deemed to be included in the value based fees and time based fees paid.

#### C2.1.6.3 Drawing duplication

- (a) For drawing duplication the standard rate as set out in Table 2 in the "Rates for Reimbursable Expenses" may be claimed or may be claimed according to the provisions as in (b) or (c) below.
- (b) If the Service Provider undertakes the duplication of drawings, using his own duplication equipment, he shall be paid the actual cost incurred on condition that it is not higher than the lowest of three quotations of local firms doing drawing duplication in his locality. Such quotations must accompany his account.
- (c) If the Service Provider does not undertake his own drawing duplication, he shall be paid the lowest of three quotations of local firms doing plan printing in his locality. Such quotations must accompany his account.
- (d) Should there not be three firms doing drawing duplication in his locality, it must be mentioned on his account and the available quotation(s) must then accompany the account.

(The cost of providing all polyester negative prints required to form part of the original set of drawings, as-built drawings including computer assisted drawing records for all facets/disciplines involved in the project are included in the tendered fees and will not be reimbursed separately.)

#### C2.1.6.4 Forwarding charges

- (a) Only the charges in respect of the forwarding of parcels by courier or air freight on special request by the Employer will be refunded, provided that such charges will not be refunded if the request had been made as a result of a delay caused by the Service Provider.
- (b) The cost of postage, facsimile transmissions, telephone calls, e-mails, etc, is deemed to be included in the value-based fees and time based fees paid.

#### C2.1.7 Travelling and subsistence arrangements and tariffs of charges

Notwithstanding the ruling in C2.1.2.4 above (regarding disbursements and travelling expenses which will not be paid separately), when the Service Provider is requested in writing by or obtained prior approval in writing from the Employer to attend specific meetings at any of the Employer's offices or any extraordinary meetings on site or elsewhere, he will be remunerated according to the provisions under C2.1.7.1 to C2.1.7.5 herein.

#### C2.1.7.1 General

The most economical mode of transport is to be used taking into account the cost of transport, subsistence and time. Accounts not rendered in accordance herewith may be reduced to an amount determined by the Employer.

As the tariffs referred to hereunder are adjusted from time to time, accounts must be calculated at the tariff applicable at the time of the expenditure.

Where journeys and resultant costs are in the Employer's opinion related to a Service Provider's malperformance or failure, in terms of this Contract, to properly document or co-ordinate the work or to manage the Contract, no claims for such costs will be considered.

#### C2.1.7.2 Travelling time

Fees for travelling time are as set out in Table 8 in the "Rates for Reimbursable Expenses".

Fees are payable for travelling time at the tariff, as set less 2 hours of each journey on time charges for work done under a value based fee. Ti

Travelling costs will be refunded for the full distance covered per return trip measured from the office of the Service Provider appointed.

Compensation for the use of private motor transport will be in accordance with the Government tariff for the relevant engine swept volume, up to a maximum of 2100 cubic centimetres, prescribed from time to time and as set out in Table 3 in the "Rates for Reimbursable Expenses".

#### C2.1.7.4 Hired vehicles

In cases where use is made of hired vehicles, the most economical sized vehicle available is to be used but compensation shall nevertheless be restricted to the cost of a hired car not exceeding a capacity of 1600 cc. Where use of a special vehicle is essential (e.g. four track or minibus to accommodate more people), prior approval in writing must be obtained from the departmental project manager.

#### C2.1.7.5 Subsistence allowance

The subsistence allowances are as set out in Tables 4 and 5 in the "Rates for Reimbursable Expenses".

Only actual costs are payable in respect of absence from office of less than 24 hours.

Should the daily tariff as set out in Table 4 be inadequate, substantiated actual costs plus a special daily allowance as shown in Table 5 for incidental expenses, may be claimed. It must be noted that claims may only be according to Table 4 or Table 5. Accommodation should be limited to the equivalent of a three star hotel and no alcoholic beverages or entertainment costs may be claimed for.

# C2.2 Activity Schedule

- C2.2.1 Activities
- C2.2.1.1 The services as defined in the Scope of Services are required. The activity schedule below lists the normal services as defined in the Government Gazetted as well as additional services as defined in the Scope of Services, of this document.
- C2.2.1.2 The estimated normal fees have been calculated using the Government Gazetted Tariffs by applying the applicable fee scale given for a building project, to determine the basic fee and by multiplying the basic fee by the applicable multiplication factor given respectively.

No allowance has been made in the estimated normal fees for the additional services that have been specified to be included in the normal fees. The tenderer shall make provision for the cost of the additional services that are to be included under normal services by adjusting the percentage tendered.

- C2.2.1.3 The services are to be provided in stages and the proportioning of the fee for normal services over the various stages shall be as set out in the Government Gazetted Tariffs
- C2.2.1.4 The tenderer must make provision for all activities necessary for the execution of the service as set out in the Scope of Services.
