SPECIFICATION, EVALUATION PREFERENCE POINT SYSTEM & PRICING SCHEDULE

1. BACKGROUND

General Justice Gizenga Mpanza Regional Hospital formerly known as Stanger Hospital is a 500bedded Regional and District Hospital with the inclusion of the new 176 bedded Neo natal and maternity ward located in KwaDukuza within iLembe Health District. The Hospital serves an estimated population of 600 000 from iLembe District.

The GJGMR Hospital has grown from a District Hospital to a Regional Hospital with an expansion of services offered. As such, the hospital infrastructure requires upgrades and additions, to effectively provide for the expansion of the package of care offered.

Additionally, the hospital supports 9 clinics. Amongst other things, the hospital ensures provision of inventory to these facilities on a weekly basis. Clinics which are supported are as follow:

- Ballito Clinic
- Shakaskraal Clinic
- Groutville Clinic
- Glenhill Clinic
- Nandi Clinic
- Darnall Clinic
- Kearsney Clinic
- Mpumelelo Clinic
- Mobile Clinics

The construction of the new warehouse, bulk store and archive on the new Greenfield site ERF 261 would require a road and bridge linking to the existing General Justice Gizenga Mpanza. The estimated square meter of the bridge is estimated to be above 100m2 across a streamline separating the two sites.

2. PURPOSE

The Department is seeking bids from experienced and skilled Environmental Assessment Practitioner that must be registered with South African Council of Natural Scientific Professions (SACNASP) or EAPASA. Sci. Nat.) to provide services at the KZN Department Of Health: General Justice Gizenga Mpanza Regional Hospital (Stanger Hospital): for the construction of new link road and vehicular bridge.

The Registered Professional Environmental Assessment Practitioner (Pr.Sci.Nat or EAPASA.) will be appointed to perform all project deliverables but not limited to **the National Environmental Management Act 73 of 1998 (as amended): Environmental Impact Assessment Regulations** (2014, as amended) and the National Water Act (36 of 1998).

3. SCOPE OF WORK/SPECIFICATION

3.1 Scope of Work

The objective of the project is to provide a warehouse that will accommodate the following:

- Bulk Storage space/ inventory
- SCM Department offices
- Oxygen Bay/Gas storage
- Flammable stores
- Board of survey/condemned items (Equipment)
- Pharmacy Storage- with separate access and temperature controlled storage
- Card board bay
- Archives
- Parking space, loading and separate fencing enclosing all
- Security room and toilet
- All services connections including IT and telephone

Currently the bulk stores are being accommodated in a leased warehouse, located approximately 1.7km away from the hospital. The building was leased in 2004 and expired in 2005, now the warehouse is leased on a month to month basis.

The size of the current leased warehouse is 614 square meters, which is inadequate to cater for the hospital's needs. The total estimated floor coverage for the new warehouse is 2107 square meters excluding circulation.

The proposed development activity involves the construction of a new link road and vehicular bridge across ... river/stream (Insert Name of the watercourse) to link the existing Stanger Hospital to the new warehouse site. A locality map is attached as Annexure 1 to this BID. The proposal requires Environmental Authorisation in terms of GNR 326 (LN1) of the NEMA: EIA Regulations (2014, as amended) and water use authorisation in terms of Section 21 of the National Water Act (36 of 1998) will also be required.

During the construction phase, the appointed service provider will be required to perform Environmental Control Officer Duties (ECO) for a period of 24 months. Fortnightly site visits and a monthly audit must be undertaken.

3.2 **Procurement Objectives**

The commissioning of professional services is the design, documentation and subsequent monitoring and management of the new construction of new road & bridge, bulk store, archives and fencing. Professional services provided will be commissioned under the following general deliverables during the project stages indicated below:

- STAGE 1: Project Initiation and Briefing
- STAGE 2: Concept and Viability
- STAGE 3: Design Development
- STAGE 4: Design Documentation and Procurement
- STAGE 5: Construction Documentation and Management
- STAGE 6: Handover
- STAGE 7: Close-out

The appointed Service Provider must therefore undertake the Environmental Impact Assessment process as documented in Chapter 4 and Appendices 1, 4 and 6 of the EIA Regulations.

The recommended deliverables below are the minimum, but not limited to, for the successful completion of the project objectives:

- 1. Basic Assessment Process:
 - a. Four (4) client and Project team meetings;
 - b. Two site visits;
 - c. Pre-application meeting with the Department of Economic Development, Tourism and Environmental Affairs (EDTEA);
 - d. Review and confirmation of the EIA triggers, authorisation requirements and authorisation process, and required specialist studies;
 - e. Public Participation process (notification, signboards, adverts, etc.) as per Chapter 6 of the EIA Regulations;
 - f. Appointment and management of specialist studies as determined by EDTEA and approved by the client;
 - g. Undertaking of the Basic Assessment process in terms of the EIA Regulations;
 - h. Basic Assessment Report compliant with Appendix 1 of the EIA Regulations;

 - d. Appointment and management of specialist studies as determined by DWS and approved by the client.
 - e. Risk assessment;
 - f. Public participation (if required, can be combined with the Basic Assessment Process);
 - g. Compilation of the Integrated Water and Waste Management Plan (IWMMP) in line with DWS format requirements;
 - h. Completion of the Water Use Authorisation application forms;

Environmental Control Officer Duties:

- 2. The ECO must undertake fortnightly site visits and a monthly audit.
- 3. Review the environmental file and method statements.
- 4. Undertake an environmental awareness training session (yearly) for the duration of the construction phase, i.e. x 2 sessions, prior to the commencement of site clearing and construction activities.
- 5. Approve the site camp location.
- 6. Undertake a pre-construction audit.
- 7. Monitor compliance against the Environmental Authorisation, Water use Authorisation and EMPr.
- 8. Produce an audit report in terms of Appendix 7 of the EIA Regulations (2014, as amended).
- 9. Identify non-compliances and environmental issues during site visits and the monthly audit report.
- 10. Perform an advisory role for the duration of the construction phase.
- 11. Submission of the monthly audit report to EDTEA.
- 12. Undertake a post-construction audit on completion of the construction phase and identify environmental snags to be closed out by the contractor.

 - (iii) registered technicians**: 16,5 cents for each R100,00 of his/her gross annual remuneration; provided that this hourly rate shall not exceed 16,5 cents for each R100,00 of the total annual remuneration package attached to the lowest notch of a level 11 salary range (Deputy Director first leg) in the Public Service.

*(includes professional architects, professional quantity surveyors, professional engineers, professional technologists [engineering], professional planners and professional construction project managers)

**(includes professional technicians [engineering] professional senior technologists [architectural], principal technologists [architectural] and technical planner).

Hourly rates calculated in terms of (i), (ii) and (iii) above shall be deemed to include overheads and charges in respect of time expended by clerical Personnel which shall, therefore, not be chargeable separately.

- C2.1.3.5.3 Unless otherwise specifically agreed in writing, remuneration for the time expended by principals in terms of C2.1.3.5.2 (i) above on a project shall be limited to 5 per cent of the total time expended for time charges in respect of the Project. Any time expended by principals in excess of the 5 per cent limit shall be remunerated at the rates determined in (ii) or (iii) above.
- C2.1.3.5.4 Notwithstanding the above, where work is of such a nature that Personnel as described in C2.1.3.5.2 (iii) above are capable of performing such work, it shall be remunerated at that level and not at the rates described in (i) and (ii) above, irrespective of who in fact executed the work.
- C2.1.3.5.5 Gross annual remuneration in C2.1.3.5.2 (iii) above shall mean basic salary and guaranteed annual bonus; fringe benefits not included in basic salary; income benefit, as determined from time to time by the South African Revenue Services for income tax purposes, for the private use of a motor vehicle by the employer; employer's contribution to pension/provident fund, medical aid and group life assurance premiums; Compensation Fund and Unemployment Fund contributions, Metropolitan Council levies and any other statutory contributions or levies; all other costs and benefits as per conditions of appointment but excluding any share of profit and payment for overtime.
- C2.1.3.5.6 The salaries referred to in C2.1.3.5.2 (i) to (iii) above can change from time to time, which will, therefore, change the rates applicable. These rates will, however, only be adjusted on the first day of each calendar year irrespective of any changes in salary ranges during the relevant year. The rates <u>applicable at the time of the execution of the work</u> as set out in Table 8 of the "Rates for Reimbursable Expenses", as amended from time to time, may be claimed.

C2.1.3.6 Additional Services

C2.1.3.6.1 Additional Services pertaining to all Stages of the Project

Unless separately provided for hereunder and scheduled in the Activity Schedule, no separate payment shall be made for the additional services specified in Government Gazette, BN 122 of 2015, 12 June 2015. The cost of providing these services shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.6.2 Construction monitoring

The construction monitoring requirements are as specified in 3.2 (Procurement Objectives) but not limited to the specified scope of services.

- (a) If <u>Level One, part time</u>, monitoring has been specified then no separate payment shall be made for construction monitoring staff as specified in C3.3.2.2 (i)-(iii) or for the transport of the monitoring staff as specified in C3.3.2.2 (iv). The cost of providing construction monitoring staff and transport shall be deemed to be included in the value based fee tendered for normal services.
- (b) If <u>Level Two, full time</u>, monitoring has been specified then provision shall be made in the Activity Schedule for the envisaged site staffing requirements as specified in C3.3.2.2 (i)-(iii). The unit of measure shall be the rate per calendar month (pro rata for part of a month). Payment shall only be applicable for the period actually established on site and shall in no instance be prior to the date of official handover of the Works to the Contractor or after the date of issue of the Certificate of Completion for the Works contract. The rates tendered for the relevant site staff shall include full compensation for all costs including, inter alia, the following:
 - Salary
 - Additional allowances
 - Bonuses
 - Leave and sick leave
 - All company contributions such as provident fund, group life benefits, medical aid etc.
 - Levies
 - Office equipment as set out in C3.3.2.2 (iii)
 - Relocation cost and accommodation
 - Travelling
 - Handling cost and profit.

Payment for personnel shall exclude any periods of leave or sick leave. Time sheets for staff shall be included in the monthly fee account submitted to the Employer for payment. Replacement of staff as a result of any extended period of leave or sick leave outside of the normal contractor's year end break shall be to the approval of the Employer.

No separate payment shall be made for the transport of the construction monitoring staff as specified in C3.3.2.2 (iv) and the cost of the transport shall be deemed to be included in the monthly rate tendered for the provision of the staff.

C2.1.3.6.3 Occupational Health and Safety Act, 1993 (Act No. 85 of 1993)

No separate payment shall be made for the service specified in C3.3.2.3. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.6.4 Quality Assurance System No separate payment shall be made for the implementation of a quality management system as specified in C3.3.2.4. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.6.5 Lead Consulting Engineer No separate payment shall be made for assuming the leadership of an Employer specified joint venture, consortium or team of consulting engineers as specified in C3.3.2.5. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.6.6 Principal Agent of the Client

No separate payment shall be made for assuming the role of principle agent of the Employer if specified in C3.3.2.6. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

- C2.1.3.6.7 Environmental Impact Assessment No separate payment shall be made for the service specified in C3.3.3.1. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.
- C2.1.3.6.8 Other unspecified services The Employer may order duties that fall outside the scope of the project as tendered. Such additional duties may involve, but not limited to:
 - Additional design requirements
 - Evaluation of alternative tenders
 - Additional investigations during the Defects and Liability Period
 - Diverse other services

Any such additional services that may be required will be remunerated on a Time Basis as set out in C2.1.3.5. The level of expertise necessary for any such additional work shall be concomitant with the issues to be addressed. The category of personnel necessary to undertake the work shall be approved by the Employer. Any additional identified service shall be fully scheduled and submitted to the Employer for approval prior to the commencement thereof.

C2.1.4 Time based fees

C2.1.4.1 Fees for work done under a time based fee

Where time based fees are payable (if basis of remuneration has been set at "time basis" according to C2.1.1.1), the principles as described in clauses 4.4 (1), (2) and (3) of the 2010 NDPW - Scope of Engineering Services and Tariff of Fees, excepting that the rates referred to in clause 4.4 (3) shall be replaced by the <u>various rates</u> per hour tendered for the various categories in C2.2.3 Activity Schedule for Time Based Fees, column (e). These rates will be used for the <u>full Period of Performance</u>.

- C2.1.4.2 The various categories (referred to in C2.2.3 Activity Schedule for Time Based Fees, are the categories described in clauses 4.4 (2) of the 2010 NDPW Scope of Engineering Services and Tariff of Fees.
- C2.1.4.3 Work will be remunerated for at the category level in which it falls as defined in C2.1.4.2 above, irrespective of whether the person who in fact executed the work functions at a higher category of responsibility and competence.

C2.1.5 Set off

The Employer reserves the right to set off against any amount payable to the Service Provider, any sum which is owing by the Service Provider to the Employer in respect of this or any other project.

C2.1.6 Typing, printing and duplicating work and forwarding charges

C2.1.6.1 Reimbursable rates

The costs of typing, printing and duplicating work in connection with the documentation which must of necessity be done, except those which must in terms of the relevant Manual or other instructions be provided free of charge, shall be reimbursable <u>at rates applicable at the time of the execution of such work</u>. The document "Rates for Reimbursable Expenses" as amended from time to time and referred to below, is obtainable on the Employer's Website: <u>*http://www.publicworks.gov.za/*</u> under "Documents"; "Consultants Guidelines"; item 1.

C2.1.6.2 Typing and duplicating

If the Service Provider cannot undertake the work himself, he may have it done by another service provider which specialises in this type of work and he shall be paid the actual costs incurred upon submission of statements and receipts which have been endorsed by him confirming that the tariff is the most economical for the locality concerned.

If the Service Provider undertakes the work himself, he shall be paid in respect of actual expenses incurred subject to the maximum tariffs per A4 sheet as set out in Table 1 in the "Rates for Reimbursable Expenses".

Typing and duplicating expenses shall only be refunded in respect of the final copies of the following documents namely formal reports, formal soil investigation reports, specifications, feasibility reports, bills of quantities, material lists, minutes of site meetings and final accounts. The cost of printed hard covers shall only be paid in respect of documents which will be made available to the public such as bills of quantities and specifications or where provision of hard covers is specifically approved.

The typing of correspondence, appendices and covering letters are deemed to be included in the value based fees and time based fees paid.

C2.1.6.3 Drawing duplication

- (a) For drawing duplication the standard rate as set out in Table 2 in the "Rates for Reimbursable Expenses" may be claimed **or** may be claimed according to the provisions as in (b) or (c) below.
- (b) If the Service Provider undertakes the duplication of drawings, using his own duplication equipment, he shall be paid the actual cost incurred on condition that it is not higher than the lowest of three quotations of local firms doing drawing duplication in his locality. Such quotations must accompany his account.
- (c) If the Service Provider does not undertake his own drawing duplication, he shall be paid the lowest of three quotations of local firms doing plan printing in his locality. Such quotations must accompany his account.
- (d) Should there not be three firms doing drawing duplication in his locality, it must be mentioned on his account and the available quotation(s) must then accompany the account.

(The cost of providing all polyester negative prints required to form part of the original set of drawings, as-built drawings including computer assisted drawing records for all facets/disciplines involved in the project are included in the tendered fees and will not be reimbursed separately.)

C2.1.6.4 Forwarding charges

- (a) Only the charges in respect of the forwarding of parcels by courier or air freight on special request by the Employer will be refunded, provided that such charges will not be refunded if the request had been made as a result of a delay caused by the Service Provider.
- (b) The cost of postage, facsimile transmissions, telephone calls, e-mails, etc, is deemed to be included in the value based fees and time based fees paid.

C2.1.7 Travelling and subsistence arrangements and tariffs of charges

Notwithstanding the ruling in C2.1.2.4 above (regarding disbursements and travelling expenses which will not be paid separately), when the Service Provider is requested <u>in writing</u> by or obtained prior approval <u>in writing</u> from the Employer to attend specific meetings at any of the Employer's offices or any extraordinary meetings on site or elsewhere, he will be remunerated according to the provisions under C2.1.7.1 to C2.1.7.5 herein.

C2.1.7.1 General

The most economical mode of transport is to be used taking into account the cost of transport, subsistence and time. Accounts not rendered in accordance herewith may be reduced to an amount determined by the Employer.

As the tariffs referred to hereunder are adjusted from time to time, accounts must be calculated at the tariff applicable at the time of the expenditure.

Where journeys and resultant costs are in the Employer's opinion related to a Service Provider's malperformance or failure, in terms of this Contract, to properly document or co-ordinate the work or to manage the Contract, no claims for such costs will be considered.

C2.1.7.2 Travelling time

Fees for travelling time are as set out in Table 8 in the "Rates for Reimbursable Expenses".

Fees are payable for travelling time at the tariff, as set out in C2.1.3.5 Time charges for work done under a value based fee. Travelling time will be fully reimbursed.

C2.1.7.3 Travelling costs

Fees for travelling costs are as set out in Table 3 in the "Rates for Reimbursable Expenses".

Travelling costs will be refunded for the full distance covered per return trip measured from the office of the Service Provider appointed.

Compensation for the use of private motor transport will be in accordance with the Government tariff for the relevant engine swept volume, up to a maximum of 3000 cubic centimetres, prescribed from time to time and as set out in Table 3 in the "Rates for Reimbursable Expenses".

C2.1.7.4 Hired vehicles

In cases where use is made of hired vehicles, the most economical sized vehicle available is to be used but compensation shall nevertheless be restricted to the cost of a hired car not exceeding a capacity of 1600 cc. Where use of a special vehicle is essential (e.g. four track or minibus to accommodate more people), prior approval in writing must be obtained from the departmental project manager.

C2.1.7.5 Subsistence allowance

The subsistence allowances are as set out in Tables 4 and 5 in the "Rates for Reimbursable Expenses".

Only actual costs are payable in respect of absence from office of less than 24 hours.

Should the daily tariff as set out in Table 4 be inadequate, substantiated actual costs plus a special daily allowance as shown in Table 5 for incidental expenses, may be claimed. It must be noted that claims may only be according to Table 4 <u>or</u> Table 5. Accommodation should be limited to the equivalent of a three star hotel and no alcoholic beverages or entertainment costs may be claimed for.

C2.2 Activity Schedule

C2.2.1 Activities

C2.2.1.1 The tenderer must make provisions for all activities necessary for the execution of the services(s) as set out in the applicable Government Gazette and as further deemed necessary to undertake the works to all deliverable stages.
