- Proof of Valid Registration with CIDB
- Proof of Registration with (CSD) Central Supplier Database
- Valid Certified BBBEE Certificate
- Company Structure and CV of personnel
- List of completed projects and current projects and minimum of 3 references
- Proof of Business Address (electricity bill/letter from Traditional Council)
- Proof of Disability (where applicable)
- Vat Registration Certificate / Number
- Military Force Number (where applicable)
- Completed declaration forms (SBD 4, SBD 8, and SBD

VERY IMPORTANT:

- The advert will be open to all contractors with emphasis on Youth, Women, People with Disabilities and Military Veterans Contractors and Beneficiaries will be admitted.
- All information submitted will be verified.
- The contractors will be admitted in all categories.
- The contractor can only belong to one District Forum where the company is based.

- The successful applicants will be integrated in the current ECDP database, which will be advertised upon expiry of validity period.
- The directors/owners of more than one company only one company will be admitted, the other companies will be disqualified.
- Only Military Veterans who are registered on the National Military Veteran's database will be admitted.
- Only Contractors who submit the proof of permanent disability from the registered medical practitioner will be admitted under the people with disabilities category.
- Failure to produce any of the statutory documents will result in your company being disqualified from the programme.
- The duration of the Eyesizwe Contractor Development Programme database is from 2019- 2024.
