7. Only locally produced goods or locally manufactured goods meeting the stipulated minimum threshold for local production and content will be considered; refer to SBD 6.2 and Annexure C in tender documents.
8. The Department reserves the right not to award more than one service to any single entity or JV, Multiple awards will be limited per entity. Multiple awards will be limited and aligned to capacity, ability to complete scheduled work within time and budget.
