- 6. Proof of payment from the bank will be needed prior to handing over the Bid document, No EFT payments and its proof will not be accepted.

- 7. Bid documents must be collect prior to the starting time of the tender briefing meeting. No tender documents will be issued at the tender briefing meeting and not Site Inspection meeting certificates will be issued at the Tender briefing meeting.
- 8. Bidders who attend without a bid document will not be allowed to the briefing.
- 9. The Site Inspection certificate must be signed and stamped by the Department representative, during the briefing as proof of attendance, and should it not be signed your tender document will be disqualified.
