- 3. The Department reserves the right not to award to the lowest bidder. In addition, the Department will conduct a detailed risk assessment prior to the award of the bid.
- 4. Bids documents will be issued at the pre tender briefing meetings, bidders to furnish proof of payments and the payment must be done separately for each bid, No Electronic Funds Transfer (EFT) payments will be accepted and site inspection meeting certificates will be issued at the pre tender briefing meeting. No document will be issued to the bidder who do not proof of payment
- 5. Tenderers are required to send competent persons to the tender briefing meetings that are directly involved in the filling in and the completion of the tender document to add value to the discussions at the tender meetings.
