- 7. Submission of a PDF copy of the completed bid tender document together with all supporting tender documents must be submitted on a readable compact disc together with the bid at close of tender.

- 10. Only Bidders registered on the Central Suppliers Database and within the applicable CIDB grading 1GB and above will be legible to submit bids/quotations.

11. Bidders must submit Certified B-BBEE or EME certificates issue by Verification Agency accredited by SANAS or original sworn affidavit signed by commissioner of oaths (copy of copy not allowed). All B-BBEE certificates that have been issues by verification agencies or professions who are not accredited by South African National Accreditation Systems will be rejected. Valid Tax clearance.
