1. The Department reserves the right not to award to the lowest bidder.
2. In addition, the Department will conduct a detailed risk assessment prior to the award of the bid.
3. The bid document can be downloaded from e-Tender Portal at no cost.
4. No tender documents will be issued at the tender briefing meeting and no site inspection meeting certificate will be issued at the tender briefing meeting.
5. Proof of payment from the bank will be needed prior to handing over the Bid document, No EFT payments and its proof will not be accepted. Original deposit slips issued only and stamped by the bank teller.
6. Tender Documents must be purchased prior to the starting time of the tender briefing meeting.
7. Bidders who attend without a bid document will not be allowed to the briefing.
8. Late submissions will not be accepted.
9. Faxed or e-mailed bids are not accepted.
10. Only Bidders registered within the applicable Central Suppliers Database (CSD) and CIDB will be eligible to submit bids.

Multiple awards shall be limited to the ceiling value of the applicable CIDB grading of the recommended bidder unless previous contracts awarded has been more than 60% completed in terms of the actual scope of the contract and time expended are within the allocated timelines of the contract period of the contract with specific reference to the activity-based construction program and concise demonstration has been given that the bidder has the capability and resources to complete the project successfully.
