5. Posted, Faxed or e-mailed quotes are not accepted.
6. Only Bidders registered on the Central Suppliers database and registered as Professional Engineering Surveyors as listed in the document will be legible to submit quotes.
7. The Department reserves the right not to award to the lowest bidder.

8. In addition, the Department reserves the right to conduct a detail risk assessment prior to the award of the quotation.
