- 2. Under no circumstances whatsoever may the bid document be re typed or re drafted and only bids submitted on the bid document issued by the Department will be accepted.
- 3. Bid documents must be downloaded or purchased and collected prior to the starting time of the pre tender briefing meeting.
- 4. No bid documents will be issued at the pre tender briefing meeting and no site inspection meeting certificates will be issued at the pre tender briefing meeting.
- 5. Bidders need to submit the hard copy of the original completed bid/tender document Volume 1, together with all supporting documents and must submit the fully completed electronic excel bills of quantities on the attached flash drive (part and parcel of the purchased bid document), at close of bids.
- 6. - 13. Bidders' attention is drawn to the Mandatory criteria as listed in the bid document as well as the phased sequence of the bid evaluation process.

Multiple awards shall be limited to the ceiling value of the applicable CIBD grading of the recommended bidder unless previous contracts awarded has been more than 60% completed in terms of the actual scope of the contract and time expended are within the allocated time lines of the contract period of the contract with specific reference to the activity based construction program and concise demonstration has been given that the bidder has the capability and resources to complete the project successfully.
