4. No bid documents will be issued at the pre tender briefing meeting and no site inspection meeting certificates will be issued at the pre tender briefing meeting.
5. Bidders need to submit the hard copy of the original completed bid/tender document Volume 1, together with all supporting documents and must submit the fully completed bills of quantities at close of bids.
6. Late submissions will not be accepted.
