- 3. In addition, the Department will conduct a detailed risk assessment prior to the award of the bid. Multiple Awards of bids will be limited in order to spread the work amongst a large number of successful bidders, see Tender document for further elaboration.
- 4. Tender documents must be collected prior to the starting time of tender briefing meeting. No tender documents will be issued once the tender briefing meeting has started.
- 5. Proof of payment from the bank will be needed prior to handing over of the bid document, and EFT payment and its proof will not be accepted.
- 6. Bidders who attend without a bid document will not be allowed to the briefing.
- 7. The Site Inspection Certificate must be signed and stamped by the Departmental Representative during the briefing as a proof of attendance, and should it not be signed your document will be disqualified.
- 8. No late arrivals will be admitted to the tender briefing meeting.
