- 2. The Department reserves the right not to award to lowest bidder
- 3. In addition, the Department will conduct a detailed risk assessment prior to the award of the quote.
- 4. Tender documents must be purchased prior to the starting time of pre-tender briefing meeting.
- 5. No tender documents will be issued at the pre-tender briefing meeting and no site inspection meeting certificates will be issued at the pre-tender briefing meeting.
- 6. Bidders who attend without a bid document will not be allowed to the briefing.
- 7. No late arrivals will be admitted to the pre-tender briefing meeting.
- 8. Submission of a PDF copy of the completed bid tender document together with all supporting tender documents must be submitted on a readable compact disc together with the bid at close of tender.
- 9. Late submissions will not be accepted.
- 10. Only Bidders registered on the Central Suppliers Database (CSD) within the applicable CIDB Grading are eligible to submit bids.
- 11. The Department reserves the right not to award more than one cluster to any single entity or joint venture. Multiple awards will only be considered in circumstances where the Department satisfies itself with the capacity and capability of the tendering entity and shall be limited to not more than two (2) clusters per entity or joint venture.
- 12. NB!! Clusters 17, 27 & 28 are OPEN and the other 09 clusters are for ECDP ONLY. CONTRACTORS WHO HAVE SUBMITTED THEIR APPLICATION FORMS TO BE REGISTERED ON ECDP PHASE 2 WILL BE ELIGIBLE TO TENDER, HOWEVER AN AWARD CAN ONLY BE CONFIRMED IF THEIR APPLICATIONS ARE SUCCESSFUL.
