Assistance provided by these institutions has drastically reduced business failure rate.

Furthermore, it is also of utmost importance for entrepreneurs to be as creative as possible. We should not enter the already saturated markets, instead we should identify the market gap so that we present convincing business plans to financial institutions when applying for finance. This can also guarantee success for our businesses.

The SMME sector will also benefit from projects such as Bridge City, Dube Trade Port and King Shaka Airport. People living within the INK area should benefit from these projects. I also want to encourage youth, women and people living with disabilities to seize opportunities provided by the Tourism sector especially in this province. Looking at exhibitions today one is convinced that there is a lot of skill, talent and creativity which showcases South Africa's capacity to provide excellent service in the tourism industry. Our heritage can generate income for the citizens of this province.

The Department of Public Works also provides assistance to entrepreneurs in the construction sector. - To create enhanced partnerships.

The department in partnership with the Construction Industry Development Board (CIDB) has established a Construction Contact Centre. This is a one stop service facility aimed at providing construction awareness and access to a broad spectrum of development opportunities available in the construction industry. I therefore wish to encourage all emerging contractors to make an effort to obtain more information about these programmes.

Lastly I want to encourage you to broaden your horizons and expand your scope in terms of your target market. As you exhibit here today your target market and potential customers may include government departments, corporate businesses and foreign sector. The government is prepared to support you in penetrating foreign market mainly within our neighbouring countries. Therefore, never underestimate the impact this business fair might have in the future of your business.
