- 4. Bidders whom elected to download the bid document must submit the complete original completed bid document together with all supporting documents at the close of bids
- 5. The bid documents must be downloaded or purchased and collected prior to the starting time of the Pre-tender briefing meeting. No bid documents will be issued at the Pre-Tender briefing meeting and no site inspection meeting certificates will be issued at the pre-tender briefing meeting.
