- 4. The bid document can be downloaded from e-Tender Portal at no cost. However, should any bidder require a printed/hard copy of the bid document, a non-refundable payment must be made before the collection of the bid document, as per the banking details indicated below. Proof of payment must be produced upon collection of the bid document.
- 5. Site Inspection meeting certificates will not be issued at the Tender briefing meeting. The Site Inspection certificate must be signed and stamped by the Department representative, during the briefing as proof of attendance, and should it not be signed your tender document will be disqualified.
