1. Contract Duration (Page 6):

The tender document specifies a contract period of 3–5 months, which appears insufficient to complete both the feasibility study and the procurement phase as outlined in the PPP Framework. Specifically, the Treasury Approval process (TA I, TA IIA, TA IIB, and TA III) alone requires a minimum of one month per TA, which accounts for four months of the contract period. Furthermore, according to PPP Manual Module 5: Procurement (pages 2–3), the procurement phase alone takes a minimum of 41 weeks.

We therefore respectfully request that the contract period be revised to reflect a more realistic timeline aligned with the scope and regulatory processes of the assignment.

ANSWER

Unfortunately, the timeline is not open for any revision.

Also note that TIIA and TIIB are not part of this contract period of 3-5 months.

2.Documentary Proof for Youth Ownership (Page 7 – Specific Goals Section):

Under the section titled "Ownership by People Who are Youth Documentary Proof Required", we seek clarity on whether a Central Supplier Database (CSD) report can be accepted in lieu of a SANAS Approved B-BBEE Certificate, especially considering that the CSD report contains relevant ownership demographics, including age.

Kindly confirm if the CSD report will be deemed sufficient for meeting this specific goal criterion.

ANSWER

CSD can only verify the youth category of persons for South African citizens. Should you not be a South African citizen, the supporting documentation to verify
