3. In addition, the Department may conduct a detailed risk assessment prior to the award of the bid.
4. Tender Documents must be purchased prior to the starting time of tender briefing meeting.
5. No tender documents will be issued at the tender briefing meeting and no site inspection meeting certificates will be issued at the tender briefing meeting.
6. Bidders who attend without a bid document will not be allowed at the briefing meeting.
7. Late submissions will not be accepted.
8. Faxed or e-mailed bids are not accepted.
9. The Preference points system is applicable for this bid is 80/20, where 20 points of specific goals will be allocated as follows:

10. Only Bidders registered on the Central Suppliers Database and within the applicable CIDB grading of 2GB OR HIGHER will be eligible to submit quotations

Multiple awards shall be limited to the ceiling value of the applicable CIDB grading of the recommended bidder unless previous contracts awarded has been more than 60 % completed in terms of the actual scope of the contract and time expended are within the allocated timelines of the contract period of the contract with specific reference to the activity based construction program and concise demonstration has been given that the bidder has the capability and resources to complete the project successfully
