3. The contractor shall achieve the measurable contract skills development goal by providing opportunities to learners requiring structured workplace learning using combination of the following in relation to work directly related to the contract.
4. **Method 2: Structured workplace learning opportunity for apprentices or other artisan learners towards the attainment of a trade qualification leading to listed trade (GGNo. 35625, 31 August 2021) subject to at least 60% of the artisan learners being holders of public TVET college qualification.**
