- 4. The bid document can be downloaded from e-Tender Portal at no cost. However, should any bidder require a printed/hard copy of the bid document, a non-refundable payment must be made before the collection of the bid document, as per the banking details indicated below. Proof of payment must be produced upon collection of the bid document.
- 5. Bidders who attend without a hard copy of the bid document will not be allowed to the briefing.
- 6. The Site Inspection certificate must be signed and stamped by the Department representative as proof of attendance, and should it not be signed your tender document will be disqualified.
- 7. No late arrivals will be admitted to the tender briefing meeting.
- 8. Late submissions will not be accepted.
- 9. Faxed or e-mailed bids are not accepted.
- 10. Only Bidders registered within the applicable CIDB grading and Central Suppliers Database will be eligible to submit bids.
