4. Late submissions will not be accepted.
5. Faxed or e-mailed bids are not accepted.
6. The Preference points system is applicable for this bid is 80/20, where 20 points of specific goals will be allocated as follows:
Ownership by black people : 10 points
Ownership by people who are youth: 10 points
7. Only Bidders registered on the Central Suppliers Database and within the applicable CIDB grading of 2GB OR HIGHER will be eligible to submit quotations
8. Multiple Awards of bids will be limited (unless by exception due to circumstance) in order to spread the work amongst many successful bidders and to minimize the risk to the Department. Multiple awards shall be limited to the ceiling value of the applicable CIDB grading of the recommended bidder unless previous contracts awarded has been more than 60 % completed in terms of the actual scope of the contract and time expended are within the allocated timelines of the contract period of the contract with specific reference to the activity based construction program and concise demonstration has been given that the bidder has the capability and resources to complete the project successfully
