6. The Preference points system is applicable for this bid is 80/20, where 20 points of specific goals will be allocated as follows:

7. Only Bidders registered on the Central Suppliers Database and within the applicable CIDB grading of 2GB OR HIGHER will be eligible to submit quotations.
8. Multiple Awards of bids will be limited (unless by exception due to circumstance) in order to spread the work amongst many successful bidders and to minimize the risk to the Department.
