Prequalifying Criteria

Evaluation Criteria

- Administrative compliance, mandatory requirements, financial offer and preference offer.

Phase 1:

Administrative Compliance

- a) Correctness of bid document

- b) Compliance with bid regulations (registration with CSD and other prescripts requirements)
- c)The bidder must quote for ALL items
- d)The bid Price must be on the pricing schedule)

Phase 2:

Mandatory Documents Requirements

- 4. Value of contract
- 5. Details of the reference for each contract
