6. The Preference points system is applicable for this bid is 80/20, where 20 points of specific goals will be allocated as follows:

 - Documentary proof Required (Sworn affidavit signed and dated by Commissioner of Oaths)
7. Only Bidders registered on the Central Suppliers Database and within the applicable CIDB grading of 2GB OR HIGHER will be eligible to submit quotations
